The Board of School Trustees of the School City of Hobart met in regular session on April 15, 2021, in the Board Room at Hobart High School, 2211 East Tenth Street, Hobart, Indiana.

EXECUTIVE SESSION: President Butler indicated that the Board did not meet in an executive session prior to the regular session.

<u>APPROVAL OF MINUTES</u>: Karen Robbins moved that the Board approve the work session, executive session, and regular session minutes of April 1, 2021. Frank Porras seconded. Vote on motion: Aye – Schultz, Porras, Rogers, Hillan, Guthrie, Robbins, and Butler. Motion carried 7-0 in favor.

RESOLUTION: Lease for Union Street Property: Attorney William Longer presented Resolution No. 2021-21 for the Board's consideration. Mr. Harders was interested in leasing the property and offered \$1,300.00 per acre for the 13 tillable acres beginning on May 1, 2021, for the 2021 farming season. Mr. Longer indicated that the resolution approved his actions in dealing with Mr. Harders and also authorized the Superintendent to execute the lease agreement for the acreage. In addition, the resolution authorized the Superintendent to extend or renew current lease terms or to secure replacement tenants for the residential and agricultural parcels.

A Resolution Authorizing Lease of Real Property Owned by the School City of Hobart

WHEREAS, the School City of Hobart has acquired real property located south of Hobart High School on Union Street; and

WHEREAS, the Board of Trustees previously determined that it is in the best interest of the School City that the acreage continue to be managed as agricultural land until such time as the parcel is needed for school purposes; and

WHEREAS, the Board of School Trustees authorized the Board Attorney to negotiate lease terms for the acreage; and

WHEREAS, a tenant has been obtained, fair rental value determined, and a Lessee obtained for the tillable acreage for one year commencing May 1, 2021 for a price of \$1,300.00; an amount which equals or exceeds the rental for the 2020 growing year; and

WHEREAS, the tenant Russell Harders, farmed the land in 2020 and is familiar with it, and was offered the opportunity to continue to farm the acreage in 2021 as a show of good faith in connection with the negotiated purchase of the land from Mr. Hrezos; and

NOW THEREFORE, BE IT RESOLVED, by the Board of School Trustees of the School City of Hobart, that the actions of the Board Attorney are approved and the Superintendent is hereby authorized to execute a lease agreement for the acreage described.

BE IT FURTHER RESOLVED, that upon expiration of the current lease terms for the residential or agricultural parcels acquired from Mr. Hrezos, the Superintendent is authorized to extend or renew the current lease terms, or to secure replacement tenants therefor.

<u>REPORT: Brickie Virtual School</u>: Dr. Peggy Buffington reported to the Board that she was exploring the possibility of opening a virtual learning school for K-12 students for the 2021-2022 school year called Brickie Virtual School. She explained that there are currently 890 E-Learning students in the district, and their parents may be interested in continuing virtual learning for their student(s) for the coming school year. She noted that the elementary schools were at 85-90% in-person learning and said the majority of E-Learners were at the high school. She said there are families who may be health comprised or just do not want to send their student(s) back to in-person schooling. Dr. Buffington indicated that the district was encouraging virtual learning, but it was being offered as an option to those families who would not be returning to in-person schooling. She indicated the virtual school would be for online learners only and would provide separate online instruction in a class setting for remote students only. Certified school district teachers would use the school district's curriculum and technology that is aligned with state academic standards, and high school students can earn a Core 40 Diploma or an Academic Honors Diploma entirely online. (Some secondary classes may only be available in-person, and parents would be required to provide transportation for their student to them. This would also be true for the required lab experiences for coursework in of some classes.) Dr. Buffington noted that parents have saved over \$1,000,000 by their students participating in the Hobart University Program. The Brickie Virtual School would be a very viable option for parents who would be choosing online education elsewhere or at charter schools. Participants in the virtual school would be committing to enrollment for at least the first semester, and class enrollments would be the determining factor as to whether a class would be offered. Dr. Buffington told the Board that school personnel would soon be calling the 890 online learning families making them aware of the Brickie Virtual School and asking them to go online to review all of the information and to complete the application if they were interested in the program. She noted that the deadline to apply is April 28 so staffing for the program can be done. In addition, Dr. Buffington indicated that registration for all students was open for the coming school year. Usually, registration was done closer to the beginning of the coming school year. The link for the Brickie Virtual School was included in the electronic meeting packet.

Elementary students, kindergarten through fifth grade, would receive daily instruction from certified school district teachers in core (mathematics, language arts, science, and social studies) and foundational elective content areas. The participation will be by live interactions with teachers and peers on a daily basis via internet-based video conferencing technology (Zoom, Google Meets, etc) and the Canvas learning management system. Secondary students, grades 6-12, would receive instruction via an online curriculum with the same core area subjects as the elementary students. Since the program was housed in an online format, students would be able to access lessons and coursework at any time, day or night, from any internet access location. Under the guidance of school district certified teachers, students would be able to work at their own pace as they work through their coursework material. Each course would have various units, modules, lessons (live and recorded), assignments and assessments. Teachers would have office hours in which students would have to set a one-on-one progress meeting.

In the discussion, Dr. Buffington was asked what the amount of reimbursement for the program would be. The last amount she had heard was 100% but noted that 85% was better than nothing. Dr. Buffington noted that a couple of area school corporations were talking about offering virtual classes and becoming open-enrollment school districts. With the drop in enrollment/ADM, this would be an option to keep Hobart students in Hobart and possibly bring back students doing online education with other school districts/programs. She said that there were still many budget unknowns with federal funding. She was asked about the one semester requirement and if a student was not functioning well with the online classes. Dr. Buffington indicated that multiple interventions would be tried, but if those failed, they probably would let the student return to in-person classes. It was noted that a number of athletes this year had been E-Learners. Dr. Buffington was asked if they would be able to be E-Learners through the proposed virtual school, and she indicted they could. She reiterated that the best option for students was being in school and noted that the middle school was a busy place because of the additional students who returned for the second semester. President Butler hoped there would not be a resurgence of the coronavirus. He appreciated all of the work that had gone into the plans for the virtual school and noted the unsettling times. Dr. Buffington noted "the unchartered waters", and she indicated she would have to register the program as a new school if the enrollment was sufficient to operate the program. That was the reason for calling it the Brickie Virtual School.

RECOMMENDATION: Summer School Additions: Superintendent Peggy Buffington noted that the Board had approved summer school recommendations at their March 18 meeting, and she wanted to add some virtual learning options in English/language arts and math in grades one through eight that would include some fun activities that would align with state standards on the allowed summer school course offerings. She indicated that the classes would be dependent on enrollment. She cited an example of a fun learning activity as doing a treasure hunt, and then having the students write an essay about what happened with the treasure hunt. Finding teachers for the regular summer school program can be difficult, but she hoped that teachers would submit proposals for a virtual class that would not necessarily meet every day but would include learning activities for students so they could have fun doing them. Dr. Buffington indicated that the school district was working with the city to put together a combined summer activities/events calendar for the community.

During the Updates/Announcement/Reports, Don Rogers indicated that the Board had not approved the additional summer school additions. President Butler then requested Board action.

Donald Rogers moved that the Board approve the summer school additions, as presented. Rikki Guthrie seconded. Vote on motion: Aye – Schultz, Porras, Rogers, Hillan, Guthrie, Robbins, and Butler. Motion carried 7-0 in favor.

 - <u>April 13</u> Jermaine Galloway, Tall Cop Virtual Presentation, HHS Great Hall, Door 1, 6-7:30 p.m. (Parents attend in person. No children allowed due to the content of the presentation.)
 Dr. Buffington indicated the presentation was for parents only because it was a drug presentation about what kinds of drugs are in the community.

was a drug presentation about what kinds of drugs are in the community and over the counter items that parents needed to be aware of. Mr. Galloway will be in Hobart and Northwest Indiana for a couple of days next week providing additional training work in drug prevention.

May 4 – E-Learning Day – Primary Election Day; and

Sixth Grade Orientation, Hobart Middle School at 7:30 a.m.

<u>May 15</u> – Junior-Senior Prom, 5:00 p.m. at Hobart High School. Dr. Buffington told the Board that Lake County was in yellow again this week, and she would be submitting a plan for the prom to the Lake County Board of Health for their consideration. She indicated that she was proud of the high school's student leaders and their sponsors for the acceptance of all of the conditions involved. One of conditions was that the prom had to be free for those attending. She indicated when the meetings first began; students thought they would be negotiating with her about the prom, but she explained to them that would not be the case because there were rules that had to be followed and told them she would be complying with them. The prom will be at the high school and will use the district's catering service for their meal, and the National Honor Society will be paying for the food for the dinner. She said the students have been very understanding and want students to attend. There will be three different eating times. Social distancing and wearing masks will be required, except when eating and for their prom picture. A red carpet Grand March will be held in the gym, dining in the Great Hall, and dancing in the Fieldhouse. Kelsey Black said she was excited about the prom and having some kind of normalcy and noted the same was true for the other students. Sandi Hillan thanked Dr. Buffington for giving the students the opportunity to have a prom and that her daughter will be able to attend.

- <u>June 10</u> HHS 2021 Senior Parade, 5:30 p.m. (Rain Date June 11 @ 5:30 p.m.) Dr. Buffington told the Board that the Senior Parade was such a success last year, they are having one this year, too.
- June 13 Graduation, 6:00 pm in The Brickyard. Dr. Buffington noted it was too early for definitive information, and Covid-19 protocols for the event will depend upon the protocols/rules in effect at that time, which will determine the number of people who can attend.

COMMENTS: From the audience, Jennifer Williams, a parent of a Joan Martin School first grader, spoke to the Board about her concerns about the pick-up procedure at Joan Martin School and felt it needed "some type of control." This is her first year at Joan Martin School, but she noted that the pick-up process at the ELC worked very well. At Joan Martin, even though students are released by grade, the students just run out to the cars, and she experienced seeing a student almost being hit today. She only saw the SRO and two faculty/staff people there to supervise. In addition, she said with people wearing masks, she thought a student could be tricked into going with a stranger. Dr. Buffington thanked Mrs. Williams for sharing her concerns. She commented that the protocol at Joan Martin had been good and was not aware of any changes, but she assured Mrs. Williams that she would look into the situation tomorrow. President Butler thanked her and noted that they would "find out where the breakdown" was. It was noted that Liberty uses placards for their car riders, too. Dr. Buffington indicated that something must have changed, and they would "get back to where it should be." She told Mrs. Williams that she wanted her to feel that her child was safe, as every child should be safe, and thanked her for her comments.

From the administration, administrators extended birthday wishes to Tim Krieg. Ted Zembala enjoyed the slide show recognition for the winter athletes. Tim Krieg echoed the previous comments, noted that he assisted with the Freshman Orientation and said it was "nice to connect with the eighth graders." He said the JROTC was to be congratulated. Dr. Buffington apologized for forgetting to tell the Board that the JROTC had their annual inspection and received a score of 999 points out of 1,000. That was the highest score Hobart's JROTC Program had received, as well as being the highest score in the country. She met with the Commander before he told the cadets their score and Lt. Col. Buhmann had her meet with cadets before they received their score. She told them how proud everyone was of them, and noted the outstanding service they provide to their school and community. Karen Robbins extended the appreciation of the Hobart Food Pantry for their outstanding fundraiser this year and noted it certainly made a difference for them. Mr. Butler commented for the audience that student groups/clubs do service and giving back to the community. Bob Glover noted that one of the varsity baseball pitchers "threw a perfect game against Westville." He indicated that he was researching information with Tom Martin and Dwight Matthys, but he thought it might be a first for the high school's baseball program.

From the Board, Board members wished Dr. Krieg happy birthday. Stu Schultz extended his thanks and appreciation to everyone for the great jobs they have done "year in and year out." Frank Porras commented that one of his daughter's missed senior activities because she participated in track, and he was pleased that there will be a prom and some activities for the seniors. Don Rogers extended congratulations to the winter athletes and thanked them and everyone who assisted them in pulling off a great winter sports season, and he thanked Dr. Buffington for making it possible. Sandi Hillan expressed her appreciation that her daughter would be able to wear her purple prom dress that has been in a closet since last year. She extended her congratulations to the winter athletes for their dedication to their respective sports and complimented the athletes for persevering and adapting to all the changes caused by the coronavirus rules/guidelines. The same was true for all of the students whether they were in-person or E-Learners. She extended her "kudos" for the seniors being able to do some special activities, too. Kelsey Black thanked everyone for all they do, especially all of her teachers who have worked very hard to make their classes, as normal as possible, for the E-Learning and in-person students every day. She extended her "kudos" to all of them for "making it look effortless." President Butler explained for the audience member that a former Board member brought the idea of student representation back from a national convention. He explained that Kelsey was one of two student representatives that serve on the Board for one year. They can participate in discussions and offer their opinions about subjects being discussed, but they cannot vote or attend executive sessions of the Board. He indicated that the program has worked out very well, and the Board appreciated their insights

and perspectives. The students also learn about the operations of the school district. Mrs. Williams noted that she remembered Kelsey from the Board meeting that was held in the Great Hall before the school year began. Kelsey extended her congratulations the JROTC and Lauren Cicillan, who was not present, as well as to her other friends who are in the program. She noted they were very deserving of the recognition. Dr. Buffington noted that Lauren had a tennis match today, which was why she was absent this evening. In addition, Kelsey extended her congratulations to one of her JROTC friends who was surprised to receive her cord today. Rikki Guthrie expressed her appreciation to all of the individual work groups that have been recognized this year. She appreciated that the Board recognized their hard work and noted that it takes everyone to get things done, and this especially true this year with the pandemic. If needed, she was available to chaperone or help with the prom. Karen Robbins extended her appreciation to all of the school district's employees for the work that they do. She extended congratulations to Bob Glover and said she was "glad to have you on board." Terry Butler commented that everyone was trying to make things as normal possible under the circumstances and commented that the students were adaptable, "much better than adults." Pat Schoon told the Board that the Administration Office had received their first call about what elementary district the Cressmoor subdivision was in. The person was planning to be in their home in August. She was asked about the Eagle Creek Subdivision, and she said that there have some calls for them, also. Don Rogers reflected back to the Board meeting where the district's Protect Brickies Plan was presented in the Great Hall before school started. There were many unknowns, but amazingly, with the school year almost over, the school district has successfully stayed open. Even though there were some tough times, the district exceeded expectations, and everyone worked together to make it happen. Sandi Hillan thanked Mrs. Williams for coming to the meeting and sharing her concerns. Jennifer Williams commented that she felt older children adapted better to E-Learning than the younger ones. She shared some personal information and said her child was happy to be in school and able to see and interact with the classroom teacher. Dr. Buffington commented that the teaching staff uses the district's curriculum which includes a social-emotional component. She commented about the length of time her child was on the school bus. Terry Butler noted that his grandson is "first on in the morning and last off in the afternoon."

ADJOURNMENT: There being no further business to come before the Board, President Butler adjourned the meeting around 8:26 p.m.
