CONSIDERATION: Trademark License Agreement - C&C Custom Shirts, LLC: Dr. Peggy Buffington presented a trademark license agreement with Courtney Osgood dba C&C Custom Shirts, LLC to use Yohan, our trademarked logo, with a 10% royalty payable to the district on a quarterly basis. The agreement is for two years from April 18, 2024, through April 17, 2026, and a copy of the agreement was attached for the Board's review.

Dr. Buffington asked the Board to approve the agreement and requested Board action.

Sandra Hillan moved that the Board approve the trademark agreement with Courtney Osgood dba C&C Custom Shirts, LLC with a 10% royalty and authorize the superintendent to sign the trademark agreement. Seconded by Donald Rogers. Vote on motion: Aye – Porras, Rogers, Robbins, Schultz, Hillan, Guthrie, and Butler. Motion carried 7-0 in favor.

<u>AUTHORIZATION: Transfer of Funds from the Education Fund to the Operations Fund</u>: In the absence of Bob Glover, Business Manager, Superintendent Peggy Buffington indicated that for the budget year

2024, \$5,936,055.00 was approved for transfer from the Education Fund to the Operations Fund. To date, zero dollars have been transferred. She said it was Mr. Glover's request that \$1,275,000.00 be transferred from the Education Fund to the Operations Fund and said this would leave a balance of \$4,661,055.00 available for transfer through the end of the calendar year.

Dr. Buffington requested Board action.

Frank Porras moved that the Board approve the transfer as presented and authorize the Treasurer of the School City of Hobart to transfer \$1,275,000 from the Education Fund to the Operations Fund. Stuart Schultz seconded. Vote on motion: Aye – Porras, Rogers, Robbins, Schultz, Hillan, Guthrie, and Butler. Motion carried 7-0 in favor.

The Authorization to Transfer \$1,275,000 from the Education Fund to the Operations Fund, as presented, displayed on the screens in the Board Room, and adopted, is as follows:

AUTHORIZATION TO TRANSFER \$1,275,000 FROM THE EDUCATION FUND TO THE OPERATIONS FUND

WHEREAS, the Board of School Trustees is the governing body of the School City of Hobart, Lake County, Indiana, and

WHEREAS, on October 19, 2023 the Board of School Trustees passed resolution 2023-28 authorizing up to \$5,936,055.00 to be transferred from the Education Fund to the Operations fund during the 2024 budget year, and

WHEREAS to date, \$0.00 has been transferred leaving \$5,936,055.00 available for transfer.

- ➤ <u>ANNOUNCEMENT: Change in First Meeting Date in July</u> Dr. Buffington told the Board, since the first meeting date in July falls on the Fourth of July, the meeting date was being rescheduled to Wednesday, July 3rd.

- ➤CITY OF HOBART & SCHOOL CITY OF HOBART ONLINE AUCTION: The School City of Hobart Service Center Departments will be participating in the City of Hobart's online auction through Kraft Auction on May 23, 2024. Some of the surplus items on their school district's list are as follows: Chevy Impala security vehicle, Kubota tractor, Kubota blowers, 8' x 24' cargo trailer, miscellaneous cafe tables, and old buses.

COMMENTS: From the administration, Dr. Peggy Buffington told the Board that the Makers Fair was fun and a great time with the students and their projects. She was proud of all of the efforts of all the students, and The PLTW (Project Lead The Way) projects were great. Due to the unseasonably warm weather, students at the high school were requesting that the air conditioning be turned on. She noted the last "Cooking with Friends" Voice and Choice at the high school had extra students stopping by for food. Some students had not been able to get in the class and a few others just knew there was food. Dr. Buffington told Maddy Burton she would miss her greatly when she leaves because she was always willing to help with functions whenever Dr. Buffington asked her to participate or help with a project. She mentioned that the Town Hall with Sal Khan would be happening on April 26, and everyone was working hard to get all of the moving parts in order. Chris King agreed that the Makers Fair was another amazing evening. He extended his thanks and appreciation to Maddy Burton for her assistance with the last minute registrations and helping to setup the spaces for those students. Chris King said the season was ending for the E-sports teams at the high school and middle school, and he indicated that just before the Board meeting, he received notification that two high school E-sports teams, Valorant and Super Smash Brothers Ultimate, would be advancing to state competition. Everyone extended their congratulations to him and the teams. He said that a middle school team made it to semi-finals and told the Board they had "an amazing first year." Dr. Buffington inquired how many middle school teams there were competing in E-sports in our area, and Mr. King responded not very many with most being more in the center of the state. Dr. Buffington and Mr. King commented on a couple of the students at the Makers Fair who had outstanding technology projects. Bill Longer commented he was sorry that he missed a couple of meetings. Everyone was glad that he was feeling better.

From the audience, Bradley Keehn commented that he enjoys hearing Mike Black speak about the student athletes because you can hear his passion as he mentions their accomplishments/successes in and out of the classroom.

From the Board, Frank Porras enjoyed the recognition of the student athletes and was equally impressed that they were also good students. Don Rogers commented that Mike Black was a great athletic director. He noted he had been an athletic director for one semester and thought it was "worse than working in the mill." He was impressed with the student athletes' GPA's. Karen Robbins commented that she always enjoys the recognition of the student athletes and hearing about their accomplishments, as well as their GPA's. She mentioned that she was back at the food pantry, and she thanked Dr. Buffington for the cereal drive from the schools. She said they really needed the cereal. Stu Schultz extended his congratulations to Chris King and the E-sports teams going to state competition and for the program's expansion to include middle school students. In addition, he noted that the athletes were impressive in and out of the classroom. Madelyn Burton congratulated the winter athletes and noted she was friends with many of them. In addition, she thanked the Board for recognizing them, and she appreciated having the opportunity to be a part of it. In addition, she offered congratulations to the Innovate WithIN students, as well as the two E-sports teams going to state. Sandi Hillan offered her congratulations to the student athletes and noted they probably do not realize the importance of those GPA's at this time in their life. She extended her appreciation to the food services employees for and for the great job they do, especially preparing two meals a day, during the school year and with the summer feed program. She extended her congratulations and appreciation to the teaching staff and commented that they were "being beat up" by the state legislators. The teachers in the district "do a wonderful job," and the district does a good job of acknowledging and appreciating what their staff does. In addition, she noted the importance of the school nurses and extended her appreciation and congratulations to them. She told Maddy Burton that she would be missed. Rikki Guthrie thanked Maddy Burton for serving with the Board, her participation at the high school, and said she would miss her and Angelina. She extended her congratulations to the food serves employees and said they were very deserving of the recognition, and she extended her thanks and appreciation for all that the teachers do for their students. Mrs. Guthrie extended her appreciation to the school nurses and commented they were "a whole other breed." She offered her congratulations to Chris King and the E-sports teams. She told the administration team "to stay strong" because the school year was "almost done." Terry Butler noted how things have changed. He commented that years ago he coached middle school wrestling, they had a small team, and there were two girls who also wanted to participate. The school administration was surprised that he was willing to let them wrestle. They did do not well, but they were there. Girls wrestling will soon be a sanctioned sport statewide, and he mentioned the increased interest in women's sports, particularly NCAA basketball. He noted Caitlin Clark's contract in WNBA basketball will be for millions of dollars. Dr. Buffington complimented Mike Black for the

videos he does at the end of each sport season. She told the Board that an area superintendent visited our Aquatic Center and another area school's facilities that were designed by the same architect, and he told her our pool was incredible. She was grateful to have the pool, and the support of the taxpayers to be able to build it. Dr. Buffington noted that some area administrators even bring their family members to our pool. Karen Robbins noted that the prime reason for the successful building projects was because Dr. Buffington was "at the helm." Dr. Buffington said it was built to be a community pool and noted that a great amount of time was spent with the designs of all of the projects. Terry Butler and Dr. Buffington explained what happened to the pool that was included in the design of the high school to Mr. Keehn. The school was designed with a 25-meter pool. As part of the school building process, state approval was needed, and the new governor, Mitch Daniels, instituted new rules/guidelines, pertaining to the costs of school projects. That meant that the state wanted \$5,000,000 cut from the building project even though there was not one remonstrance from the community to the project. The state wanted the fieldhouse removed from the project, but because the district had already received a large grant for the field house, it was decided to cut the swimming pool instead. In addition, because of the state delays in approving the project, construction costs had increased. Also, during this time, the state reduced the school district's funding by over a million dollars two years in a row. The swimming community was very upset when the pool was cut so they were willing helpers to seeing the new pool built. The community approved a capital referendum for the Veterans Elementary School @ Mundell and the Aquatic Center at the high school. It was noted that the taxpayers have been very good to the school district, and the district had the support of the senior citizens. Community support will be needed to keep transportation services "alive and going." Dr. Buffington said that there will be an upcoming work session on May 16th where long range planning for the district will be discussed. She noted the high school will be paid off in December of 2028, and it was mentioned the school still looks "brand new." Terry Butler noted that school districts were "getting squeezed more and more" by the state, and the problems that Hammond is now facing "will be spreading to the other school districts." It was noted that state funding would only be increasing by \$250,000 next year, which will not cover the cost of insurance.

ADJOURNMENT: There being no further business to come before the Board, President Butler adjourned the meeting around 8:33 p.m.
