April 3, 2025

The Board of School Trustees of the School City of Hobart met in regular session on April 3, 2025, in the Board Room at Hobart High School, 2211 East Tenth Street, Hobart, Indiana.

UPDATES/ANNOUNCEMENTS/REPORTS: The Board received the following information:

- School Information – weekly agendas from all of the schools, and the April Monthly Activity Calendar from the Early Learning Center. There were no BricksCenter newsletters on March 23 and March 30.
- Upcoming Activities/Events – the latest list of upcoming activities/events. Dr. Buffington highlighted the following upcoming activities/events, as follows:

- April 7 – 11 – Week of the Young Child
Dr. Buffington hoped it would not rain on bubble day.
- April 9 – Incoming Freshman Parent Night, HHS Great Hall, 5-7:00 pm
Dr. Buffington hoped all parents would be attending since the new diploma requirements would be presented.
- April 11 – Freshman Orientation (morning at HMS including lunch and afternoon at HHS)
- April 14- May 9 – ILEARN Test Window for Third to Eighth Graders
- April 16 – Makers & Innovators Showcase, HHS Fieldhouse, 6-8:00 pm
Dr. Buffington noted this was one of her favorite events of the year.

COMMENTS: From the administration, Peggy Buffington told the Board it had been a busy week giving out BEOP's (Being Excellent On Purpose). She mentioned the JAG program (Jobs for America's Graduates) at the high school and noted it was the first year for the program that was subsidized by the state. The program is a state-based, national non-profit that helps high school students of promise, especially those facing challenges, achieve graduation and prepare for post-secondary education or careers. Today, they did their own version of "Shark Tank." The students came up with some good ideas and did "pitch presentations" for them. She said their instructor has done a great job. She said staff and students came back rested from spring break, mentioned that the school year was "in the home stretch," and noted the importance for students not to let up and "to finish strong." Bill Longer expressed his thanks to Pat Schoon "for making him look good." He mentioned that he attended Mayor Huddleston's state of the city presentation, and he recognized Vicky Ladd with an "Unsung Hero" award from the city. Mrs. Ladd was a retired school bus driver. Mr. Longer commented that throughout the Mayor's speech he used the phrase "Hobart Has It," and then he listed what the city has noting Hobart has excellent schools throughout the address.

From the Board, Dave Kostbade enjoys hearing about the BEOP recognition along the competition, as well as the cheering for their peers. He reported the Hobart Football Boosters raised over \$7,000.00 at the Moose Lodge

bingo fundraiser and said it was a little less than they received previously. Don Rogers commented that his student neighbor told him twice that he had to wait a long time for his BEOP, and Mr. Rogers told him that Dr. Buffington was very busy. Dr. Buffington indicated that she used to visit the classrooms, but now because of the large number of BEOP's, each student's name was read over the PA system, and they come to the office and pick up their BEOP and have pictures taken. Brad Keehn complimented Pat Schoon on the great job she does and said that included the time when he was on the other side of the table. In addition, he noted that he has been impressed with the leadership of the student representatives and extended his appreciation to them for "their hard work." Kayla Davis, HHS student representative, told the Board she participated in the French students' trip European trip and just returned on Tuesday. She had a great time and enjoyed the trip and made some new friendships. She said our chaperones and the other chaperones and tour guides did a great job. Isis Fleming commented that the juniors were excited about their SAT scores and thought the extra work was worth their time. She concurred with the comments about Mrs. Schoon. She invited everyone to the girls tennis team's first match at Hobart on April 9 at 4:30 pm. Frank Porras remarked that Mrs. Schoon was always professional and does an excellent job. He mentioned that he had been watched the Mayor's podcast with Dr. Buffington as his guest, and he thought Dr. Buffington did a very good job explaining the referendum. Dr. Buffington explained that there were a few glitches, but everyone pivoted so it worked out well. Because of the glitch, she was not able to use her slide presentation, and they had to take electronic comments. It was noted that there were some great responses by Dr. Krieg, Mrs. Hillan, and a couple of others to some of comments/questions, and it was mentioned that some of them were not even Hobart residents. Brad Keehn noted that anyone who was really interested could do a simple Google search to find whatever information they were seeking. He mentioned that some people "just opposed to anything." Mrs. Hillan said she knew others were responding and only responded when someone made comments that were "just wrong and out of control." Dr. Buffington stated the importance of responding to correct any misinformation because if it is not corrected, "they will believe it is true." Rikki Guthrie offered her compliments to Mrs. Schoon for the great job she does, extended her appreciation to her, and mentioned she deserved a BEOP. She was very pleased that Kayla enjoyed the trip to Europe, saw pictures on social media from the various sites they visited, and was glad she made new friends. She was glad that the Board was able to offer the students this opportunity. Isis mentioned some of the other spring sports that have begun and said the baseball team had won two games, and the softball team won their game with Chesterton. In addition, it was mentioned track would be starting within the next couple of weeks. Dr. Buffington mentioned that Russ Mellon just turned in a BEOP for Pat Schoon. Mrs. Schoon thanked everyone for the complimentary comments and Mr. Mellon for the BEOP.
